Article 3. - EVENT DETAILS

- 3.1 The 2018 Rally of the Ranges will be a Special Stage Rally held under the International Sporting Code of the FIA, the National Competition Rules of CAMS, the National Rally Code, the current South Australian Conditions of Rallying, the SA Rally Championship Series Regulations, the SA Clubman Rally Series Regulations, Event Supplementary Regulations and any Further Regulations and Bulletins that may be issued.

This Event will be conducted under and in accordance with CAMS OH&S and Risk Management Policies, which can be found on the CAMS website at www.cams.com.au. Certain public, property, professional indemnity and personal accident insurance is provided by CAMS in relation to the event. Further details can be found in the CAMS Insurance Handbook, available at www.cams.com.au.

Where there is any divergence between the current CAMS Manual of Motor Sport (hereafter referred to as CAMS Manual), the Series Conditions and Regulations and the Event Supplementary Regulations, these regulations will take precedence.

- 3.2 The rally will be Round 2 of the SA Rally Championship and will incorporate Round 2 of the SA Clubman Rally Series. The rally will be open to other eligible competitors and vehicles.

In accordance with the SA Conditions of Rally the rally qualifies for 1.5x times SARC Points.

- 3.3 The CAMS Permit Number authorising the event is 518/3006/01, which will be displayed on the official notice board at the event.

- 3.4 The length of the rally will be approximately 360 kms, including 8 special stages which have a total competitive distance of approximately 110 kms. There will be a 9 km tarmac stage, with all other stages of a gravel / dirt surface, held in the Flinders Ranges and Mount Remarkable Council areas on (closed) public and private roads.

The Clubman Rally will be approx. 260 kms including of 6 special stages of approx. 80 kms, all of gravel / dirt surface.

- 3.5 The Event will consist of two Heats on one day.
- 3.6 The rally is a blind rally with no pace notes or recce permitted.

Article 4. – VEHICLE ELIGIBILITY

SA Rally Championship and Clubman Series - Refer to Series Regulations.
Other vehicles complying with the following CAMS Regulations may enter but will not be eligible for Series Points.

- Historic Rally Cars
- Tarmac Rally Cars
- Classic Rally Cars not meeting CAMS regulations at the Organiser's discretion.

All vehicles must have approved rollover protection.

Article 5. – CREW ELIGIBILITY

- 5.1 Crews shall comprise of two persons only, both being the holders of a current relevant CAMS licence. One crew member is to be nominated on the entry form as Driver and the other member as Co-Driver / Navigator.
- 5.2 As per Series Regulations, only competitors who are members of a CAMS Affiliated Car Club in SA or the Northern Territory are eligible for Series points.
- 5.3 Apparel as per CAMS Manual Schedule D. The use of Frontal Head Restraints is strongly recommended in the Clubman Series.

Article 6. - ENTRIES AND ENTRY FEE

- 6.1 Entries must be made on the event entry form and mailed or emailed to the Event Secretary.
- 6.2 Entries are limited to 50 cars in order of receipt of paid entry.
- 6.3 The entry fee includes –
- CAMS Permit Fee
 - CAMS Road Repair Fund
 - Road Book and event map
 - Two Service Crew Registrations
 - Medical Support
 - BBQ Meal Friday and Saturday evening at Quorn for two crew members
- 6.4 The entry fee for the Event is fixed as follows:

Any deposit paid will be deducted from the Entry fee.

Article 7. - SERVICING AND REFUELLING

- 7.1 The maximum distance between nominated Service Parks will be approximately 95 kms (including 33 kms competitive).

Refuelling is not permitted in service areas, or within Town limits (other than at recognised service stations). Service crews are free to refuel cars at other locations on the rally route excluding on Special Stages, however crews are reminded that service is only permitted in designated service areas.

- 7.2 Fuel will be available at the following locations:-
- Quorn Autoport, First Street, Quorn. Unleaded, Premium unleaded (95 RON), Diesel and LPG.
 - Carling Fuels, Sixth Street, Quorn. Unleaded, Premium unleaded (95 RON), Diesel and LPG.
 - Premium Unleaded (98 RON) is available in Port Augusta

Article 8. - RECONNAISSANCE AND PACE NOTING

- 8.1 The rally is a blind event with features noted in the road book. Recce in the area is forbidden from the publishing of these Supplementary Regulations.
- 8.2 The carrying or use of any form of pace notes during the event will incur a penalty up to and including exclusion. The Stewards may impose additional penalties. Random checks may be carried out Officials of the event.
- 8.3 Road Books are available for collection at Rally Headquarters, Quorn Oval on Friday 29th June and Saturday 30th June 2018.

Article 9. – ODOMETER CHECK

- 9.1 The organiser's odometer measured km on the Quorn to Hawker Road. Start at the 80 sign immediately after Park Terrace leaving Quorn and finish at the 'Hawker 65' sign.

Article 10. - DOCUMENTATION AND SCRUTINY

- 10.1 Scrutiny and Documentation for Adelaide based crews will be at Nisscare, 15 Scan Court, ROYAL PARK 5014 from 1900 to 2200 on Thursday 28th June 2018.
- 10.2 Regional based competitors may arrange local scrutiny. The completed scrutiny form must be presented with the vehicle at Quorn on Saturday 30th June.

Article 11. - START

- 11.1 The start of the rally will be at Railway Terrace, Quorn. (adjacent to the Austral Hotel-Motel). The route from Quorn Oval to the start is in the Road Book. First car will start at 8.45am

Competitors are required to form-up prior to the start on Railway Terrace and report at their correct due start time.

- 11.2 The Clubman Rally will start from Quorn Oval Time Control 2C at approx.. 11.30am

Article 16 – PRIZES, TROPHIES AND AWARDS

- 16.1 The Trophy Presentation, based on provisional results will be held at approx.. 2130 hours on 30th June 2018 at Rally Headquarters, Quorn Oval.

Motor Sport Activities are inherently dangerous recreational activities and there is significant risk of injury, disability or death.

If you do not wish to be exposed to such risks, then you should not participate in the Motor Sport Activities.

I **acknowledge** that:

- the risks associated with attending or participating in Motor Sport Activities include but are **NOT LIMITED** to the risk that I may suffer harm as a result of:
 - motor vehicles (or parts of them) colliding with other motor vehicles or persons or property;
 - others participants acting dangerously or with lack of skills;
 - high levels of noise exposure;
 - acts of violence and other harmful acts (whether intentional or inadvertent) committed by persons attending or participating in the event; and
 - the failure or unsuitability of facilities (including grand-stands, fences and guard rails) to ensure my safety.

EXCLUSION OF LIABILITY, RELEASE & INDEMNITY

In exchange for being able to attend or participate in the Motor Sport Activities, I **agree**:

- to **release** CAMS and the Entities to the extent that any or all of them are providing Recreational Services from all liability for:
 - a) my **death**;
 - b) any **physical or mental injury** (including the aggravation, acceleration or recurrence of such an injury);
 - c) the contraction, aggravation or acceleration of a **disease**;
 - d) the coming into existence, the aggravation, acceleration or recurrence of any other **condition, circumstance, occurrence, activity, form of behaviour, course of conduct or state of affairs**:
 - i. that is or may be harmful or disadvantageous to me or the community; or
 - ii. that may result in harm or disadvantage to me or the community, howsoever arising from my participation in or attendance at the Motor Sport Activities;
- to **indemnify and hold harmless and keep indemnified** the Entities to the maximum extent permitted by law in respect of any Claim by any person; and
- to attend at or participate in the Motor Sport Activities **at my own risk**.

I **understand** that:

- nothing in this document excludes, restricts or modifies any rights that I may have as a result of significant personal injury that is caused by the Reckless Conduct of the Entities as the supplier of the Motor Sport Activities / Recreational Services;
- nothing in this document prevents the Entities from relying on any laws (including statute and common law) that limit or preclude their liability;
- nothing in this document excludes any term or guarantee which under statute cannot be excluded; however the liability of the Entities is limited to the minimum liability allowable by law;
- nothing in this document precludes me from making a claim under a CAMS insurance policy where I am expressly entitled to make a claim under that insurance policy; and
- CAMS has arranged some limited personal injury insurance coverage which may provide me with some protection for loss, damage or injury that I may suffer during my participation in the Motor Sport Activities. However, I acknowledge and accept that the insurance taken out by CAMS may not provide me with full indemnity for loss, damage or injury that I may suffer during my participation in the Motor Sport Activities, and that I may have to pay the excess if a Claim is made under an insurance policy on my behalf. I agree that my own insurance arrangements are ultimately my responsibility and I will arrange any additional coverage at my expense after taking into account CAMS insurance arrangements, this document and my own circumstances.

Where Motor Sport Activities are held in the following jurisdictions, I acknowledge that I have also read and accept the following warnings:

WARNING APPLICABLE IN RELATION TO MOTOR SPORT ACTIVITIES HELD IN VICTORIA

WARNING UNDER THE AUSTRALIAN CONSUMER LAW AND FAIR TRADING ACT 2012:

Under the Australian Consumer Law (Victoria), several statutory guarantees apply to the supply of certain goods and services. These guarantees mean that the supplier named on this form is required to ensure that the recreational services it supplies to you:

- are rendered with due care and skill;
- are reasonably fit for any purpose which you either expressly or by implication, make known to the supplier; and
- might reasonably be expected to achieve any result you have made known to the supplier.

Under section 22 of the **Australian Consumer Law and Fair Trading Act 2012 (Vic)**, the supplier is entitled to ask you to agree that these conditions do not apply to you. If you sign this form, you will be agreeing that your rights to sue the supplier under the **Australian Consumer Law and Fair Trading Act 2012** if you are killed or injured because the services were not in accordance with these guarantees, are excluded, restricted or modified in the way set out in this form.

- a. "CAMS" means the Confederation of Australia Motor Sport Ltd.

- c. "Entities" means event and competition organisers/promoters/managers, land and track owners/managers/administrators/lessees, CAMS affiliated clubs, state and territory governments and insured listed in CAMS' public/product/professional indemnity insurance policies **and** each of their related bodies corporate (including their related bodies corporate) **and** each of their organs and agencies, officers/president/directors/executives, employees, servants, agents, partners, providers, members, competitors, drivers, co-drivers, navigators, officials, crew members, pit crew, delegates, licence holders, representatives, commissions, committees, advisers, trustees, councils, panels, shareholders, volunteers, officials, appointees, delegated bodies and sponsors.
